#### **ENA Conference**

Alaska ENA will provide delegate reimbursement for the following General Assembly Conference Fee (there is currently no fee for the General Assembly), air fare, lodging, transportation and food (but not alcohol). The responsibilities of those that attend as delegates include:

1. Contact members to talk about the resolutions proposed and bring resolutions to the Alaska State Council Board for discussion. Participate in the teleconference prior to the assembly.

2. Attend all business sessions & special delegate activities at the General Assembly.

3. Attend the General Assembly sessions and participate in the voting process. Must attend the entire assembly.

4. Represent the entire State of Alaska.

#### **ENA General Assembly Coming in**

#### September

The Alaska ENA BOD is looking for a few good nurses to attend the ENA General Assembly in Austin Texas this coming September! If chosen (based on points) Alaska ENA will provide a stipend to cover airfare, lodging and per diem (not to exceed a set amount!). Additionally, if you stay for the convention the Alaska ENA BOD will include an additional amount to help with registration and expenses!

As usual the selection will be based on points!

7. Instructor status for TNCC, ENPC (1 point for each course)

Projects (legislative involvement, public education, fund raising) (1 point)

10. Research in Emergency Nursing (1 point per topic)

11. Publishing on topics related to emergency care (1 point per article)

12. In the event of a tie for points, the first person in the tie who submitted their application will be chosen.

All applications will be verified and The Alaska State Council will review and choose the delegates based on points and budgeted slots. The delegates will be notified by the President and published in the newsletter. If for any reason a delegate is unable to fulfill the duties of a delegate, the alternate delegate will be offered the delegate position. The original delegate shall forfeit their reimbursement and the alternate delegate will be reimbursed.
