The number of cosponsors has increased to 82 following ENA's Day on the Hill for the Workplace Violence Prevention for Health Care and Social Service Workers Act. Be sure to check out the latest edition of the Journal of Emergency Nursing. All the articles are related to workplace violence. ENA has sent out a position statement for review. The statement is "Violence and the Impact on the ED Nurse." Please submit your comments/reviews by June 26th. Early bird registration for Emergency Nursing 23 ends on July 19th. Be sure to register as soon as possible. ENA's General Assembly is September 20-21st in San Diego. If you are interested in being a Virginia delegate for GA, please submit your application by July 7th. There is an Emerging Professional Social Hour scheduled for June 28th. There is a morning and evening session. You do not have to be a member to attend. ENA is currently updating their membership portal. This may affect your access to your profile during the update. ENA Advantage now has an app for quick access to discounts on travel, dining, and more. ENA University is now offering a CEN Review class. It has shown to increase pass rates to 70% compared to BCEN's review having a 50% pass rate. ENA University now has a Nurse Residency Program for new grad nurses and new-to-ED nurses. Residency programs have shown to increase recruitment and retention of nurses.

3. Treasurer's Report

Discussion/Summary: Main account \$191,660.94. Debit account: \$1,858.76. Chapters: \$160,547.55 as of 5/31/23. As a resolution to the recent fraudulent charges made to the VENA debit account, Parker now receives text message alerts for any credit card usage. Chapter account closures and the transfer of funds to the VENA Bank of America umbrella accounts are underway. The goal is to have all chapter accounts closed and all funds transferred by July 15, 2023. An email was sent out to Chapter Treasurers on June 8th outlining the process to close chapter accounts and move funds to the new Bank of America accounts. Chapter Treasurers will either write a check for the remaining balance of accounts, or transfer funds electronically to the new accounts. Once the funds have cleared, chapter treasurers will need to close accounts and send any remaining statement and account closure paperwork to the VENA Treasurer. Membership assessments were already transitioned to the new accounts in April. Reimbursements will now be handled at the state level. A DocuSign account has been created to submit reimbursement forms. A new travel reimbursement form will go into effect on July 1, 2023. This form mirrors the National ENA reimbursement form that most state councils are using. All donations made by the chapters for the ENStrong State Challenge were submitted by the May deadline. Total raised on the VENA ENStrong page was \$6,665.00.

Senator Tim Kaine has signed on to the Workplace Violence Prevention for Health Care and Social Service Workers Act. As a direct effect of DOTH, over 60 new co-sponsors signed on to this act. What we do really matters and makes a difference. Rear Admiral Denise Hinton gave a wonderful speech at DOTH.

ENA is also advocating for the Improving Mental Health Access for the Emergency Department Act. This has not been introduced in the House of Representatives yet.

3. Injury Prevention Committee (**Stewart**) See report. The last meeting was held in May and had 18 attendees. June is Gun Safety Awareness month. Stewart is assisting chapters with Stop the Bleed training at all the June meetings. Tidewater held their Stop the Bleed training this week and Central VA is holding their training next week. Please reach out to Amy Stewart if you are interested in having a Stop the Bleed Training. Sara Munoz, Tidewater Chapter President, and Gun Safety Workgroup Chair, recently coordinated with other ENA members to attend a Gun Violence Awareness walk in Newport News. October is Burn Awareness month. The next Injury Prevention Committee meeting will be August 2nd at 3PM EST to discuss plans for October. Recent CarFit events were very successful. More events are scheduled for later in the year. Youth of Virginia Speaks Out (YOVASO) is looking for speakers for drunk driving education in local schools throughout the state.
4. Pediatric/ENPC Committee (**Jamerson**) No report submitted. Instructor meeting today following this meeting. The meeting will be highlighting the changes in the new 6th edition.
5. Trauma/TNCC Committee (**Sullivan**) See report. Instructor meeting today following this meeting. Instructor update for the 9th edition will roll out in July. Instructors will be emailed a link to order a new book. The test will cover the instructor update as well as the book, so please be sure to buy your new book. Indirect fees are increasing to \$95. Price for book will be increasing to \$80. The student fee will be staying at \$110. The last day to teach the 8th edition will be October 28th. You will not be allowed to teach the 9th edition until you complete the instructor update. Please reach out to Kristal Sullivan if you need any help with this transition.

- 9. Education Committee (**Sullivan**) See report. The Nurse Planning Education packet is completed for the Annual VENA Conference and is scheduled to go to peer review. Will be using RegFox again for conference registration. Pre-registration will open soon. Pricing will be the same as last year for attendees and vendors. Recognition dinner is scheduled for October 19th. Cindy Hearrell is working on securing a sponsor for this dinner. The conference will be held at the Place at Innsbrook on October 20th. Silent Auction will still be held. The suggestion was made to have sign-up sheets for VENA Committees to encourage attendees to join.
- 10. EMS Advisory Board Representative (**Smith**) No report submitted. Vice Chair, Valerie Quick, present for today’s meeting. At the most recent Advisory Board meeting, there was a big discussion on EMS crew wait times in some Virginia EDs. Some EDs have had EMS crews wait with their patients for significant amounts of time either in the ambulances or inside in hallways. This violates several rules. A statement will be made soon regarding this problem.
- 11. Virginia EMSC (**Rasmussen**) See report.
- 12. Remembrance Committee (**Preuss**) No report submitted. Committee chair, Bonnie Preuss, recently lost her husband. VENA has sent her a card and flowers.
- 13. Ad Hoc Workgroup: State Restructuring (**Hearrell/Scott**) See report. The last meeting was held via Zoom on May 17th. There was a lot of discussion about the lack of chapter compliance and overall lack of engagement. Rappahannock chapter has officially been closed due to lack of compliance. Cindy Hearrell reached out to a few two-tier states, and all had very positive things to say about being a two-tier state. The Workgroup recommends that VENA make the switch to a two-tier structure and have chapters become Special Interest Groups (SIGs). The Workgroup will continue to meet to help with the transition process and to take a closer look at VENA procedures. The next meeting is scheduled for July 7th at 3PM EST. Everyone is welcome to attend.

A total of \$325,158 was raised which is still more than last year (\$312,000 was raised in 2022). 7. New Business

Discussion/Summary: *State Restructuring.* Following the recommendations from the State Restructuring Workgroup, the VENA Board of Directors has made the decision to move the state to a two-tier status. Chris Parker abstained from this vote since he is currently sitting on the National Board of Directors. Prior to today's meeting, Teri Diloy spoke with all Chapter Presidents to make them aware of this decision. Per Teri, there is a general sense of relief from the presidents. Chapters will become Special Interest Groups (SIGs). This will allow for continued local leadership, but with less responsibility. Finances will be the responsibility of the state council. This change will also allow the state to consolidate our resources and put more time, effort, and resources into our committees. The State Restructuring Workgroup will continue to meet to advise and oversee the details of this change and write this into our procedures. The next meeting is scheduled for July 7th at 3PM EST.
